LEGISLATIVE PRIORITIES

As the 501(c)(4) branch of Women4Change, the W4C Action Fund has identified four primary areas for legislative advocacy in order to secure the dignity, autonomy, economic well-being, and physical safety of all Hoosier women.

Economic Stability

We support women's economic stability by advocating for childcare accessibility, paid family leave, eliminating the period tax, and closing the wage gap.

- Childcare is unaffordable for typical families in Indiana. Ex. A typical family would have to spend 38.7% of their income on childcare for an infant and a four-year-old.
- Indiana ranks 44th out of 50 states and DC for the gender pay gap, according to business.org.
- Indiana is 1 of 22 states that still taxes period products. 1 in 4 Hoosier menstruators significantly struggles to pay the costs.

Women's Health

We support policies that promote women's health, including defending and protecting reproductive choice, equal access to birth control, ensuring that LARC (Long-Acting Reversible Contraceptives) are available to women while they are still hospitalized after giving birth, and accessible mental health care.

- We will advocate against further restrictions on abortion access and barriers to birth control.
- Over 80% of all pregnancy-related deaths are preventable. The top 3 causes include mental health conditions, hemorrhage, and cardiac and coronary conditions.
- More than 650,000 Hoosiers live in an obstetric desert. Women of color are more likely to face maternal health challenges than white women.

Sexual Harassment, Assault, and Consent

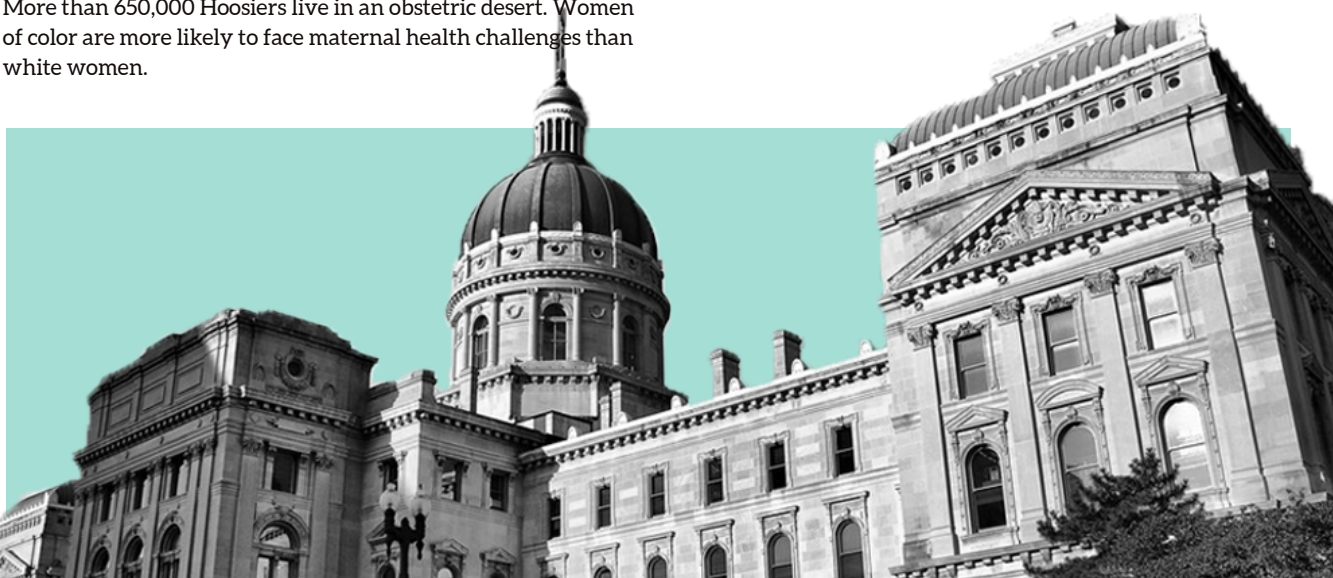
We support legislation that recognizes rape by impersonation and closes loopholes in the state's sexual assault and harassment statute.

- Currently, there is no law against rape by impersonation, where the perpetrator conceals their identity and convinces the other person that they are someone else in order to gain sexual assent. An amendment might change that.
- State sexual harassment code governs employers with 5 to 15 employees and requires the employer to agree to a lawsuit before the victim can file. This makes these cases nearly impossible to pursue.

Voter Access

We support accessible, fair voting access for every citizen and ending the current process for establishing legislative districts that leads to non-competitive districts, lower voter turnout, and lack of representation.

- Indiana consistently ranks in the bottom 10 states for voter turnout.
- A primary barrier to high voter turnout is reduced polling places in communities of color.
